

FOWLER CEMETERY BOARD MEETING JUNE 25, 2024



Jeff Simonian motioned the bills be paid. David Muro Second. Motioned Carried. David stated to the Board that on Monday June 24, 2024 a rain storm along with thunder and lightning came over the cemetery grounds. The Large pine tree was struck by lightning and large portions of the pine tree fell on the Cemetery's landmark granite sign and the wrought iron fence. The sign fell over but was not damaged, but one side of the iron fence was damaged and is in need of repair. Rico's Memorials was contacted the day of the storm and came out the next day to assess the granite sign and determined that there was no damage to the granite stone. On Monday July 1, 2024 Rico and his crew and placed the granite sign back on its base. The cost to re-install the sign was \$950.00. The next meeting was announced for Thursday July 25, 2024.
